ORDER

WHEREAS, in terms of Sub-clause (10) of Clause 8 of National Council of Teacher Education (Recognition Norms and Procedure) Regulations – 2014 and Section 26A of the West Bengal Primary Education (WBPE) Act (amended up to date), 1973, RAIPUR RABINDRA VIVEK D.EL.ED. INSTITUTE, BURDWAN had applied for grant of renewal for continuing the D. El. Ed. Course Vide application ID No. 202403643139 and submitted the hard copy of documents with undertaking to the WBBPE physically.

- AND WHEREAS, on scrutiny of the application submitted by the institution, the certificate of recognition received from the Eastern Regional Committee of NCTE under memo No. F.NO.ER-269.6.22(PART-LL)/ERCAPP3291/D.EL.ED./2019/59667 Dated:03.03.2019 the WBBPE is satisfied that the applicant fulfills the requirements under the provision of West Bengal Primary Education Act (amended up to date), 1973, Regulations and the relevant Rules including the Norms and Standards as set by the Board adhering the NCTE guidelines for the D. El. Ed. Training programme such as instructional facilities, infrastructural facilities, financial resources, etc. for running the programme.
- 3. NOW THEREFORE, in exercise of the powers vested under section 26A of the West Bengal Primary Education (WBPE) Act (amended up to date), 1973, the WBBPE hereby grants renewal of affiliation to RAIPUR RABINDRA VIVEK D.EL.ED. INSTITUTE, BURDWAN (as Bengali Medium Institute) for conducting Two-Year D. El. Ed Course with an intake capacity of 100 (One hundred) for the academic year(s) 2023-2025 subject to the fulfilment of the following terms and conditions: -
 - (i) The institution shall comply with various norms and regulations of NCTE, 2014 and West Bengal Primary Education Act, (amended up to date), 1973 and other regulations/rules/guidelines as issued by West Bengal Board of Primary Education from time to time.
 - (ii) The institution shall make admission of candidates to the course as per regulations/norms/guidelines as prescribed by WBBPE.
 - (iii) The institution shall be guided by the NCTE Regulation, 2014 in respect of appointment of teaching and non-teaching staff, purchase of books, audio visual materials and automation of library.

- (iv) The institute shall be obliged to follow the fee structure, and other terms and conditions as specified by State Government/WBBPE/Competent Authority of NCTE from time to time.
- (v) The institute shall follow the academic and financial discipline strictly as per norms of NCTE and Orders/Rules/Guidelines issued by the State Government/Affiliating Authority time to time especially with respect to minimum number of teaching days in an academic session as stipulated by the affiliating authority/NCTE.
- (vi) The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- (vii) The institution shall make available the list of the students admitted on its official website.
- (viii) The building of the Institution, hostels or other infrastructures or the play grounds shall be used only for the purpose for which it has been affiliated.
- (ix) The premises of the Institution should be kept open for inspection by any authorized persons of the West Bengal Board of Primary Education and the concerned persons authorized by Law.

The West Bengal Board of Primary Education is empowered to withdraw/cancel the affiliation, if it considers that the act and activities of the Institution are against the interest of the students or anything in violation of the above-mentioned conditions.

Non-fulfilment of any of the above conditions shall be treated as breach of conditions of affiliation. The West Bengal Board Primary Education, in exercise of its power as the affiliating body, may withhold or withdraw the affiliation, leading to the cancellation of the NCTE Recognition.
